Ridge Runners Range Rules

- Be prepared to produce your current membership card. You will be asked to leave without it.
- 2 Members are authorized to have only one guest.
- 3 Members are responsible for their guests and minor children.
- 4 Members or their guests who violate the range rules will be asked to leave and may face expulsion from the club.
- 5 Shooting hours are from 8:00 a.m. to 1/2 hour after sunset.
- 6 **NO** drugs or alcohol allowed.
- \overline{NO} skeet shooting allowed.
- 8 NO glass targets! No stumps or logs are to be placed on the range.
- 9 <u>NO</u> metal targets unless used at an authorized event.
- 10 Ground targets are not permitted in front of or on the target supports.
- 11 Do **NOT** shoot at any part of the target support structure.
- Wear appropriate eye and hearing protection.
- 13 Exercise safe gun handling practices at all times.
- 14 Know where others are at all times.
- 15 Keep muzzle pointed in a safe direction.
- Avoid an accidental discharge by keeping fingers outside of the trigger guard until ready to fire.
- 17 Ensure that **no** shots stray outside the backstop area of the range.
- 18 Unload, open the action, remove magazine and ground/bench all firearms during a cease-fire.
- 19 Do <u>NOT</u> handle any firearm or stand at the firing line where firearms are present while others are down range.
- 20 Be certain the ammunition matches the firearm being used.
- Pick up any debris from your shooting session (i.e.: ammo boxes, paper/cardboard targets, cans, etc.) and place in appropriate trash receptacle. **Pick up your own brass!**
- 22 Be sure to close and lock the gate when leaving the range.

Report range violations <u>immediately</u> by calling: 518-236-7349. This is your range! Enjoy it! Keep it safe and clean!

MEMBERSHIP TERM & DUES

Membership terms run from January 1 through December 31 annually. We do not prorate the membership dues.

The following are the annual dues for each type of membership:

Membership and how it relates to spouse/partner and children: Family memberships are extended to the immediate family being defined as the spouse/partner and children age 20 and under residing in the applicant's home. Children through age 20 residing at home or away at college qualify. Any child who is 18-20 is required to submit his or her own separate signed release annually. At age 21, a child previously listed under a family membership must complete and submit an individual membership application using the individual membership renewal fee of \$20.00 instead of the new membership fee of \$55.00. If you previously had an individual membership and you now want a family membership, select "Renewal Family Applicant" on page 1, and pay the renewal family membership dues of \$35.00.

We do not accept debit or credit cards or any type of electronic payment (i.e., PayPal). We only accept checks or money orders. There will be a \$35.00 fee on any returned checks. You are required to submit your membership application, release, and payment by mail. Scanned copies sent by email <u>will not</u> be accepted. Same-day service <u>is not</u> offered, no exceptions. Plan accordingly!
